A panel will review the submissions and present Governor Reeves with the top (3) entries for each category for the Governor to make the final decision. Nominators will be notified by April 28th if your nominee won an award. The award will be presented at the Governor's Awards Luncheon on May 22nd at 12:00 P.M. during the Public Safety Summit at the Sheraton Refuge Hotel and Convention Center in Flowood, Mississippi.
